**CALL FOR ADMISSIONS**  
**FIRST LEVEL MASTER'S COURSE / PROFESSIONAL MASTER'S COURSE IN**  
**FINANCIAL & RISK MANAGEMENT**  
**Academic Year 2025 - 2026**

The First Level University Master's Programme / Professional Master in "*Financial & Risk Management*" has a duration of 1 (one) year and is conducted in English. This program is jointly organized with the University of Bologna "Alma Mater Studiorum" and concludes with the awarding of a joint degree from both Universities.

**Available slots and admission requirements**

For the academic year 2025 – 2026, the First Level University Master's Programme / Professional Master in "*Financial and Risk Management*" offers a total of 35 slots for Albanian candidates, 10 for international candidates, and 5 for candidates from Kosovo, North Macedonia, Montenegro, Presevo, Bujanovac, and Medvegja.

For candidates to be admitted to the First Level Master / Professional Master's Degree Course in "*Financial and Risk Management*" candidates must have at least a three-year/bachelor's degree from courses accredited and completed in Universities equally institutionally accredited in the country of origin at the time of issue, in:

- Management and Administration
- Economic and business administration sciences.
- Economic and statistical sciences.
- Mathematical sciences.
- Political sciences and international relations.
- Other faculties are deemed suitable by the Commission.

**Participation Modalities**

For the candidates who shall apply for admission, they must complete the online registration procedure on the OLCG Catholic University portal: <http://admissions.unizkm.al/> by **03/10/2025**, attaching an electronic copy in PDF format (pdf/A) scan of the following documentation:

- a. Undergraduate Diploma
- b. Degree certificate with the list of grades issued by the University of origin.
- c. Any assessable qualifications (specialization and upgrade courses, language courses, Masters, etc.)

- d. Curriculum Vitae signed and
- e. A valid identification document (passport or identity card).
- f. Personal photos.
- g. Declaration according to Annex no. 1 which is an integral part and attached to this Call
- e. B1 Certificate<sup>1</sup> of english language issued by a recognised entity from the Ministry of Education and Sport (Cambridge, IELTS, TOEFL, TOEIC, GESE, APTIS).

Foreign candidates, after uploading the documents listed above, must pay the registration fee of 50 euros within **08/10/2025** as per the formats below:

- in cash at the University Student Admissions Office available from Monday to Friday, from 08:00 to 16:30.

Eligible candidates are Albanian citizens and citizens from Kosovo, Macedonia and Montenegro etc. who, after uploading and the relevant verification of the documentation, are considered suitable to proceed and pay 2,000 ALL (lekë) for the registration application within **08/10/2025**.

Payment is made in the same way as mentioned above.

The enrollment status can be checked by accessing the reserved area on the University portal.

### Selection modality

The Candidates will be listed based on the submitted documentation.

If the number of candidates is higher than the expected slots, a motivational interview and the English language test will take place on **10/10/2025**, in the headquarters of the Catholic University "Nostra Signora del Buon Council" in Rr. "Dritan Hoxha", Tirana, Albania.

## Registration/enrollment

For registration purposes, candidates who will be declared winners based on the results and available slots must submit the following documents in hard copy to the Didactic Secretariat, in person or through a representative with a proxy, on **27/10/2025**:

1. Receipt of the bank payment order of the first installment or the entire annual tuition fee (the payment order is downloadable from the student portal: [portal.unizkm.al](http://portal.unizkm.al), item: "Tariffs").
2. Diploma, and the grade list/diploma supplement, or a copy of the original, of the first cycle of studies completed in the Republic of Albania. First cycle diploma of studies completed abroad, accompanied by a true copy of the original, or, if not in possession, the candidates shall submit another official document on the basis of which equivalence has been made in the Republic of Albania, issued to the country in which he/she conducted his/her studies, so that it enables the candidate to enroll and attend second cycle studies. Candidates who have not yet finalized the diploma recognition and equivalence process can submit the application submission certificate to NESC for recognition and equivalence.
3. The admission application submission form (referred to in Annex no. 2 attached to this Call)
4. Copy of identity document.
5. Two personal photos.
6. Any assessable qualifications (specialization and upgrade courses, language courses, Masters, etc.)
7. B1 level certificate<sup>2</sup> of the English language issued by an entity recognized by the Ministry of Education and Sport (Cambridge, IELTS, TOEFL, TOEIC, GESE, APTIS).
8. Only for candidates who obtained their degree abroad: The document of equivalence<sup>3</sup> of the degree issued by the National Education Service Center of the Republic of Albania, in original or certified copy. As required by the Joint Order of the RASH and QSHA n. 112 of 05/07/2024 there is an obligation to present this document by **30/03/2026**.

In cases where the documentation comes from a foreign university, the documentation must have the stamp affixed by the country of origin. Furthermore, if the requested documentation coming from a foreign university is not in Albanian/English/Italian, it must be translated into the Albanian language.

Candidates who have not complied with the above-mentioned terms and conditions of registration may be registered conditionally but will not be able to take the exams for the first semester until

- Enrollment application (form available on the university portal: <https://portal.unizkm.al/#/> )
- Registration contract.
- Declaration according to Annex no.1 which is an integral part attached to Decree n. 12 dated 06.30.2023.

### **Minimum Number of participants**

For the Master to be enacted it is necessary to reach a minimum number of *registered participants*  
37 If this number is not reached, the University reserves the right to not activate the course, returning any fees already paid to those enrolled.
